Outline of the Benefit

Details of the initiative	For the purpose of reducing the financial burden of purchasing food and other daily necessities, a payment of 20,000 yen per household will be provided to households that are exempt from resident tax for fiscal year 2025, as well as households subject only to the per capita rate of resident tax.		
Eligibility requirements	Households that meet all of the following requirements are eligible: ① Members of the households shall be registered as residents of Setagaya City as of the reference date (December 22, 2025). ② Members of the households shall be composed entirely of individuals who are either exempt from resident tax or subject only to the per capita rate of resident tax for fiscal year 2025.		
Benefit amount paid	Per household: 20,000 yen	Eligible recipient	Head of household
Application deadline	June 30 (Tuesday), 2026 (postmarked on or before that date.)		
Note	Since this benefit is distributed on the basis of the City's implementation guidelines, it is classified as a gift contract. If the eligible recipient passes away after the day following the reference date (December 23, 2025) but before the gift contract is established, the handling of the benefit will be as follows: ● In the case of a single-person household as of December 22, 2025 Since the eligible household that meets the requirements no longer exists, the gift contract will not be established, and the benefit cannot be received. ● In the case of a multi-person household as of December 22, 2025 Another household member living in the same household as of December 22, 2025, will become the new eligible recipient (new head of the household) and can receive the benefit. *Individuals who joined the household on or after December 23, 2025, do not have the right to receive the benefit. If such an individual is completing the procedure, a representative application is required.

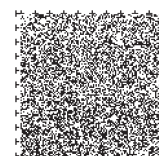

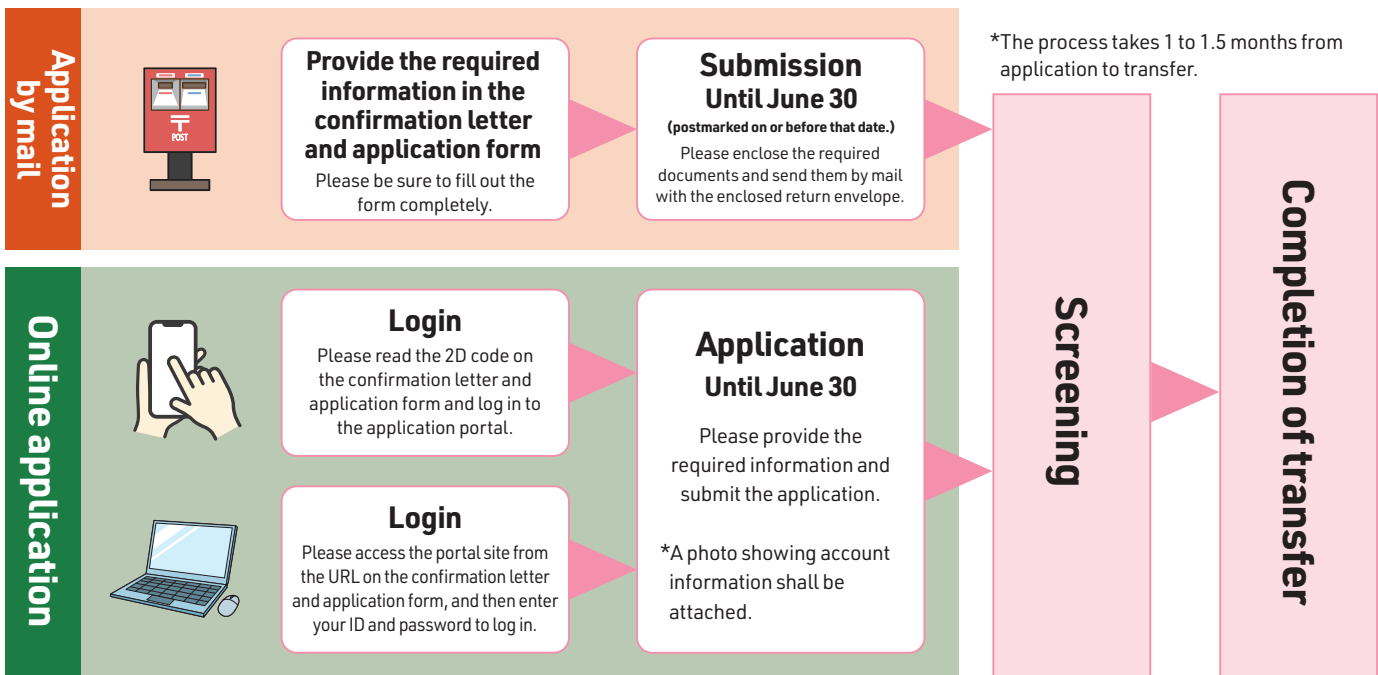

Introduction of the online application

Steps from online application to receipt of benefits

STEP 1

Login to the application portal site

Please access the application portal site using the 2D code or portal site URL in your confirmation letter and application form.

STEP 2

Apply for benefits (complete in only 10 minutes!)

Please refer to the Procedure Manual on the screen after logging in. *A photo showing account information shall be attached.

STEP 3

Check the status of your application

You can check the status of your application and the scheduled transfer date. For details, please refer to "Application Status" below.

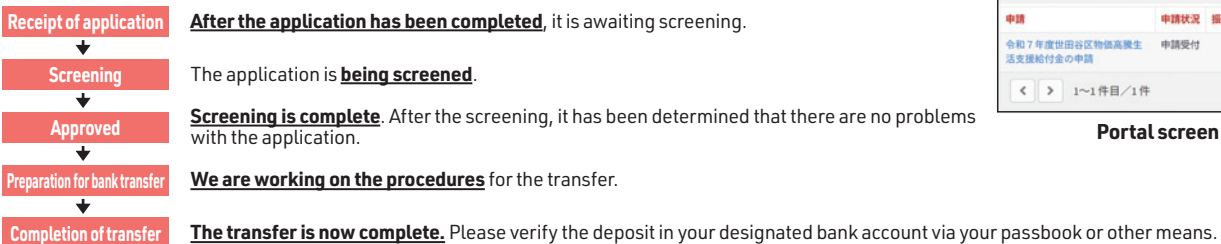
STEP 4
