

Notification of Health Examination for 18-Month-Old Children(general examination)

Setagaya City offers health examinations for 18-month-old children. This period is particularly important in terms of the healthy growth of children. We suggest that you take this opportunity and have your child receive the examination.

1. Eligible period

From 18 months old until 2 years old (2 years not included).

2. How to receive the examination

Please fill out the sections within the bolded frame (name, address, questionnaires, etc.) in the enclosed examination form and bring it to the medical institutions on the following “List of designated medical institutions for the Health Examinations for 18-month-Old Children(general examination),” together with your Maternal and Child Health Handbook.

Medical institutions may specify a date and time for the checkups in order to avoid overcrowding and to reduce risk of infection. Please enquire with the respective medical institutions in advance.

3. Examination items

Body measurement, consultation, health guidance, etc. (Items stated in the examination form)

4. Fee

Free of charge

(However, you will be charged if you receive the examination outside the eligible period, at medical institutions other than the designated medical institutions, or when you receive a test and treatment other than the items stated on the examination form).

5. Other

Based on the results of the health examination, children who will need health guidance will hear from the Public-Health Promotion Division at a later date.

In addition, we will send out information about the dental checkup carried out at the Public-Health Promotion Division next month. If your child has had the Health Examination for 18-month-Old Children (general examination), please bring the copy for the guardian of 18-month-old Health Examination (general examination) form when attending the dental checkup.
